Purpose:

The Crosspoint Holiday Bazaar has been established as a fundraiser for our KidsCamp ministry and also for our Youth Group who serve in our community and around the world. Our KidsCamp runs for one to two weeks in June with a new theme each year. We reach 100-200 kids during our full day camp along with a staff of 60. Our Youth Group serves locally at the soup kitchen and around the world in Russia with REM ministries. (Russian Encouragement Ministries)

Bazaar details:

Set up will be on Friday October 22 from 7 PM-9 PM.

Set up will be on Saturday October 23 from 8 AM -10 AM.

Show hours are Saturday October 23 from 10 AM - 4 PM

Move out will be Saturday October 23 from 4 PM -6 PM

Vendors must be set up by 10 AM and remain until 4 PM.

Booth information:

Booth size is approximately 48 feet (8' x 6', across x depth) Some corner booths may be a bit larger than this but unless 2 booth spaces have been rented, plan for these measurements and set up your display accordingly. Please DO NOT encroach your booth into the aisle way or into neighboring booth spaces as this can be both rude and a fire hazard.

Each vendor is to bring a fire extinguisher. This is a federal fire marshal requirement. Please set your extinguisher in a visible spot for the safety check 10 minutes before the doors open at 10 am.

Unless you have reserved a table and chair (\$10 fee) your booth space will be empty. And unless you reserve a booth with electricity (additional \$15 fee), none will be available for you. There is a limited number of booths with electricity running to them, so please make sure your arrangements are as early as possible.

Vendor Reminders:

No vendor can sell food or drinks without prior approval. There will be a complimentary continental breakfast available to the vendors from 8:30 - 10:00 on Saturday morning.

Offensive and/or controversial items may not be sold at the Holiday Bazaar. No exceptions to this rule!

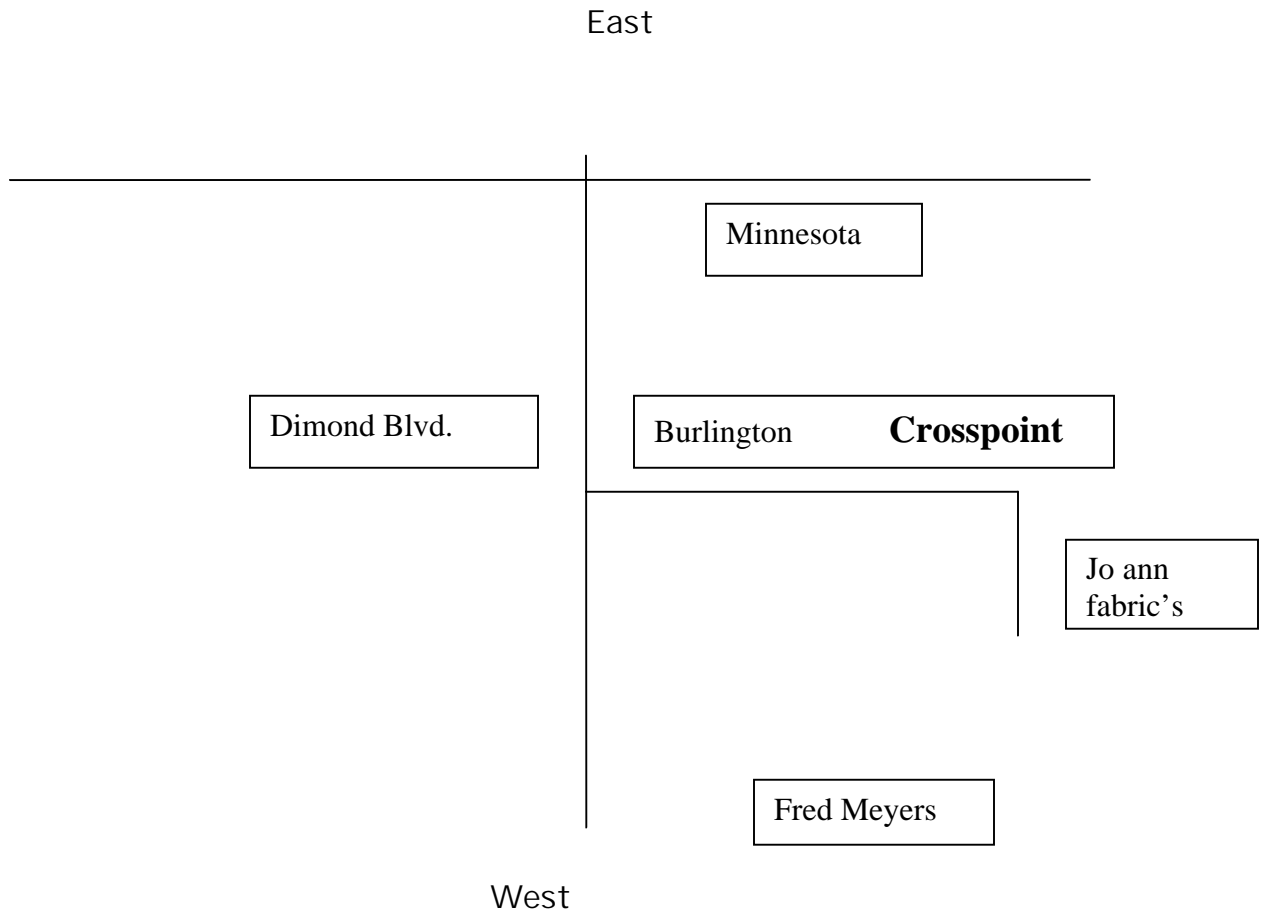
Failure to follow these rules may result in penalties assigned to the vendor and may not allow them back to future Holiday Bazaar's.
